Building on Our Strengths: Annual Meeting 2000

"If it weren't for the Coalition, I would be dead if I continued on the path I was on," said Bryan Jacobs, a past participant in the LCCH transitional housing program.

Jacobs spoke from the heart about the issues facing many homeless in Licking County and touched the hearts of more than 100 LCCH friends at the Annual Meeting 2000 held November 20 at the Cherry Valley Lodge.

Upon entering the transitional housing program, Jacobs entered treatment for drug and alcohol issues. Now in recovery, Jacobs enrolled as a student at OSU-N. For 18 months, he lived in transitional housing, worked at the campus, attended OSU-N, and took care of his two daughters. He then found permanent housing. Jacobs will graduate from OSU-N with an Associates degree this winter. He plans to work full-time and continue his education to one day become a lawyer to help low-income families.

Mary Frazell, an independent

meeting and event management consultant, was instrumental in putting together the event. Bob Seith and Shelley Miller produced the 2000 LCCH Annual Report. Frazell worked closely with the Cherry Valley Lodge, who is also very supportive of the LCCH. The Lodge was awarded a Certificate of Appreciation for their generosity not only for their help with the luncheon, but also their generous

donations of bed linens and other household items during the past several years.

Several Special Recognition Awards were presented to honor LCCH friends during the meeting. Bill Hammond accepted the honor for the St. Vincent De Paul Society of St. Francis De Sales Catholic Church.

LCCH Staff Welcome Three New Employees

The Licking County Coalition for Housing (LCCH) recently hired three new employees to add to its talented staff.

Lynn Davis of Newark came on board in September as the Individual Development Accounts (IDA) Project Coordinator.

The new IDA program helps participants double or even triple the money they save by matching funds at a rate of \$2 to \$1 for savings to buy

a home or \$1 to \$1 to further their educations. Davis recently relocated from Laurinburg, North Carolina and brings 21 years of experience with the Scotland and Richmond Counties Departments of Social Services. She lives in Newark with her husband, Bill and four children, Forrest, Grant, Michael, and Shannon.



Kelli Cox of Heath is the new Fiscal/IDA Assistant. Cox will help Davis by creating

monthly statements that will track savings and matching amounts. Cox brings several years of experience in banking and most recently worked for Core One Credit Union in Columbus as a Member Services Supervisor. She lives in Heath, with her husband, John and two children, Jamie and Bailee.



Laura Day of Millersport joined the organization in September as a Community Services Coordinator. Day brings 10 years experience in social services. Day works one-on-one with Transitional Housing program participants to help them meet immediate

needs as well as address basic issues that may have led to homelessness in the first place. The LCCH currently has two, three, and four bedroom apartments for families. There are one bedroom and efficiency apartments for single adults and couples without children.



All 40 units are completely furnished and located in Newark. Day lives in Millersport with her son, Eli.

DOUBLE OR TRIPLE THE MONEY YOU SAVE! THINK IT'S TOO GOOD TO BE TRUE?...THINK AGAIN!

How would you like to see your savings double or even triple? The new Licking County Individual Development Accounts (IDA) Program is a matched savings program designed to help income-eligible families achieve their long-term financial goals.

For every \$1 you save, the IDA program will match it with \$1 or even \$2. The IDA Program is operated by the Licking County Coalition for Housing in partnership with LEADS Community Action Agency, First Federal Savings and Loan of Newark, Licking/Knox Goodwill Industries, Licking Metropolitan Housing Authority, and the Licking County Department of Job and Family Services.

LCCH's first IDA participant, Rhonda Compton opened her IDA on November 10 at First Federal Savings and Loan. Compton's goal is to purchase a home. She is a mother of 4 and works for a local Licking County company.

Participants in this program can use their savings and match money for one or both of the following goals:

Buying a Home
Match Rate: \$2-\$1

Use your IDA for the down payment and closing costs on a home.

Continuing Education
Match Rate: \$1-\$1

Use your IDA for education for yourself or your spouse. This includes vocational/technical training, community college, 4-year college, or training to obtain a professional certificate or license.

Two new employees at LCCH are facilitating the IDA program. Lynn Davis is the new IDA Project Coordinator and Kelli Cox, new Fiscal/IDA Assistant, will help Davis by creating

statements that will track savings and matching amounts.

Who is eligible to apply for the IDA Program?

1. You must be currently employed;
2. You must have a child under the age of 18 in your household;and
3. Your monthly income must not exceed the following program guidelines:

Household Size	Monthly Income
2	\$1,407
3	\$1,769
4	\$2,132
5	\$2,493
6	\$2,856
7	\$3,219

How does the Program Work?

1. Contact Lynn Davis, IDA Project Coordinator at 349-1918 for an application.
2. Next, open your savings account,

called an Individual Development Account or "IDA", at First Federal Savings and Loan of Newark.

3. You must make regular deposits every month into your IDA Account.
4. For every \$1 you deposit up to \$1,000 per year, for the next 3 years, the Licking County IDA Program will match it according to the schedule listed above.
5. You will attend a series of workshops covering topics such as: money/time management, financial planning, goal setting, home purchasing, and financing your education.
6. You will meet regularly with IDA staff to assess your progress towards achieving your financial goals.
7. When you have met your savings goal, and have chosen a home to purchase or enrolled in school, your IDA funds will be available to defray those costs. It's that simple!

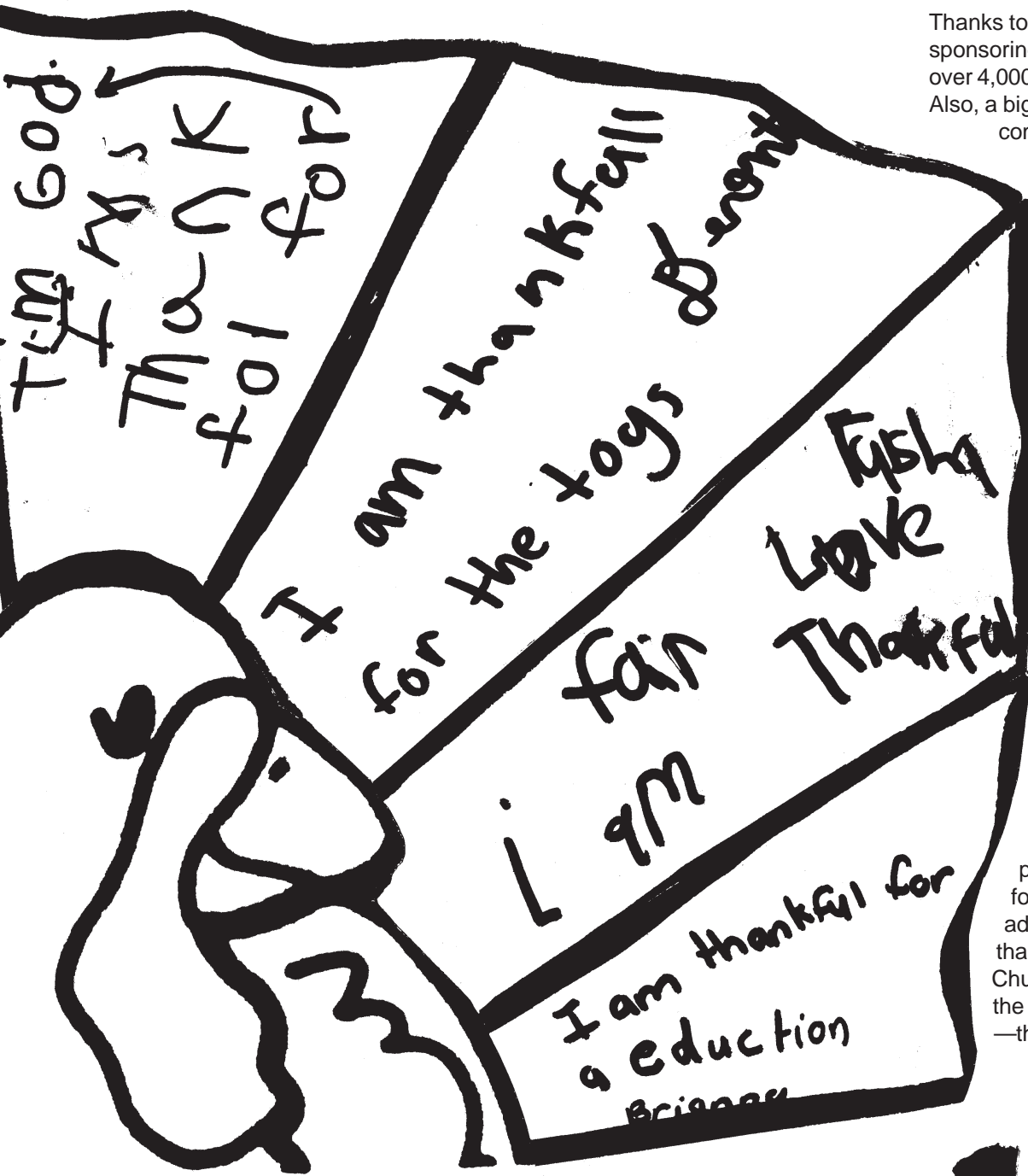

Rite Rug Steps Up to the Mat to Replace 15-Year-Old Carpeting

Many feet had crawled, walked, and played upon the 15-year-old, gold shag carpeting in 14 Transitional Housing units owned by the Licking County Coalition (LCCH) and it showed. Carpet cleaning experts said it just couldn't be cleaned anymore. It was time to be replaced.



Carl Dugan, Maintenance Coordinator and Kristin McCloud, Community Services Supervisor spearheaded efforts with Rite Rug Corporate headquarters in Columbus to step up to the mat to help conquer the huge task of replacing all the carpet in each unit and in all the halls. They provided more than 12,000 square feet of carpeting at a deep discount, which included moving furniture and installation.

"Rite Rug was more than generous," said Dugan. "We greatly appreciated their help."

A representative from The John and Mary Alford Foundation took one look at the carpet and agreed to provide \$13,225 in funding for the much-needed project and to repair the walls in the hallways of the units. The LCCH Transitional Housing program offers temporary housing for people seeking to return to permanent housing. Residents can stay up to 24 months, as long as they continue to move forward with their Individual Service Plans. Six



months of follow-up services are offered when residents leave for permanent housing to ensure they do not become homeless again.

Founded in 1993, LCCH is a one-stop shop for housing in Licking County. As a countywide partnership of businesses, churches, civic organizations, agencies, schools and caring individuals, LCCH provides housing, supportive services, technical assis-



Debi Anglin is a student in the full-time Job Training Program for Adults at the Licking County Joint Vocational School.

She attends classes three days per week and is working two days per week at LCCH as part of her training. She is currently taking on the huge task of updating the filing system, but lends a hand wherever else she is needed. Anglin started at LCCH in September and will be finished with her program in May of 2001.

"Debi has been an excellent student," said Kathy Roderick, Instructor/ Coordinator for the JVS Secretarial and Computer Training program in the Office of Technology. To be admitted into the program, a student must have a High School Diploma or G.E.D., pass an assessment and entrance interview and pay a fee. Financial aid is available.

"There is no Room at the Inn"

Over-burdened Emergency Resources Discussed During Roundtable

"There is no room at the Inn." We can appreciate these words even more during this time of the year as we scramble to provide emergency services and housing for families and individuals in need.

Twenty Licking County agencies and churches were represented recently at two Emergency Housing Roundtables held this Fall to discuss the dramatic increase in demand for emergency housing and services in our area. During April through June of this year, LCCH saw a 21% increase in demand

for services over the same period in 1999. During July through September of this year, LCCH saw a 117% increase in demand for services over the same period in 1999. Other agencies and churches reported similar increases in demand for services.

More than 20 recommendations for action were reviewed at the November discussion. The group narrowed down these actions to the following top three:

1. Need better data and data collection systems to describe and assess homeless populations.

2. Need to develop better procedures as a community to use existing emergency funds more efficiently. Consider the development of an Interfaith Hospitality Network shelter system to augment Salvation Army's services.
3. Raise public awareness of the increasing homelessness problem in Licking County. Let people know that the vast majority of homeless individuals (estimate 90%) are residents of Licking County and not from other communities, as many people believe.
